SERVICES PROVIDED

KHRS hereby agrees to provide the following services:

1. Meet individually with the client to help plan the event/performance
2. A complete compact disc sound system, which will be set up and tested before the performance.
3. Set-up and teardown of all Disc Jockey equipment used during the performance.

CLIENT RESPONSIBILITIES

Client hereby agrees to provide the following:

1. Client must submit the proposed floor plan to **KHRS** at least one week before the event.
2. Client must provide two (2) sturdy 8-foot banquet/conference/buffet tables (18" width preferred) for **KHRS** music.
(Please note that we will stack approximately 2000 CDs on these tables and they **MUST be STURDY!**)
The tables must be set up at least one and one-half hours before the time the event begins.
3. Client must provide a grounded 15 amp electrical outlet to which no other equipment is connected (dedicated circuit).
4. Client shall arrange a parking space for the **KHRS** van and pay the cost thereof, if any.

FEES AND CHARGES

The following are the fees and charges for the performance:

1. **KHRS** charges \$800.00 for the first four hours (this is our minimum charge). Additional hours are \$200.00 per hour.
2. An initial deposit of \$300.00 is required to reserve the date **KHRS** is to perform at your event. The remaining balance is due 10 days before the event/performance date.
3. Travel Expenses - Additional charges will be applied for travel expenses outside a 50-mile radius from Broomfield, Colorado.
4. ASCAP (American Society of Composers Authors and Publishers) fees can be included in the total cost of the performance. **KHRS** can arrange to provide payment of any ASCAP fees at an additional cost. Fees are determined by the type of function, the number of people in attendance, and the amount of any cover charge paid by the attendees.
5. Client is liable for any equipment damage and/or cleaning expenses incurred at the performance site.

CANCELLATIONS

1. If Client cancels the performance within four weeks of the scheduled performance date, the entire deposit will be forfeited.
2. Should it become necessary for **KHRS** to cancel the performance the entire deposit will be returned.
3. If the event is delayed as a result of the late arrival of **KHRS**, the Client shall have the option to either extend the show by double the time delay, or to reduce the fee on a pro rata basis according to the time lost.
4. If **KHRS** experiences an equipment breakdown that prevents **KHRS** from finishing the show, the fee will be paid on a pro rata basis determined by the length of playing time. This will not apply if the damage to **KHRS** equipment is caused by persons or by incidents at the event, or for electrical problems or power failures, unless such happenings are directly caused by the actions of **KHRS**.

LIABILITY

The client will indemnify, defend, and hold **KHRS** (and their employees, contractors, agents, and representatives) harmless from all actions, proceedings, claims, demands, liabilities, losses, judgments, damages, penalties, or expenses, of whatever kind, including interest, attorney's fees, court costs, and other reasonable costs and charges resulting from the negligence or intentional misconduct of the Client or third parties involved with or present at the event, including guests and venue staff. The liability of **KHRS** will not exceed the total cost of the services to be provided under this Contract.
